St Charles' Catholic Primary School has a well-established nursery, offering 15 free hours of childcare per week or 30 hours of childcare to children who are 3 years old by 1 September on the year of admission.

Our options are:

Option 1 – 15 hours

Tuesday: 8.40am - 3.20pm
Wednesday: 8.40am - 11.30am

Option 2 – 15 hours

Wednesday: 12.45pm - 3.20pm
Thursday: 8.40am - 3.20pm
Friday: 8.40am - 3.20pm

Option 3 – 30 hours

Monday to Friday
8.40am – 3.20pm

Nursery visits - You are welcome to visit our nursery on Tuesday 3 February at 4pm or Monday 2 March at 4pm to meet the staff and ask any questions you may have about school life at St Charles'.

Option 1 or Option 2 - 15 hours per week

In applying for and accepting a nursery place at St Charles' Catholic Primary School for 15 hours you are entering an agreement to use your initial 15 free hours with St Charles' for the entire academic year of 2026/2027.

Option 3 - 30 hours per week

For those parents who are eligible for the 30 hours code: In applying for and accepting a nursery place at St Charles' Catholic Primary School for 30 hours, you are entering an agreement to use your initial 15 free hours and the additional 15 funded hours with St Charles' for the entire academic year of 2026/2027. You also agree to reconfirm your 30 hours code and keep it active. **Please note: it is your responsibility to reconfirm your 30 hour code every 3 months on the Government portal.** This will affect your child's additional free 15 hour place and you may be charged the cost of the nursery place.

For those parents who are not eligible for the 30 hours code: if you wish to purchase the additional 15 hours the cost will be approximately £90 per week (to be confirmed at a later date).

- I would prefer both Option 3 (full time) and I have a 30 hour childcare code
